Information About The Enrolment Form. Please Read This Notice Before Completing The Enrolment Form.

This confidential enrolment form asks for personal information about your child as well as family members and others that provide care for your child. The main purpose for collecting this information is so that Mt. Waverley North PS can register your child and allocate staff and resources to provide for their educational and support needs. All staff at Mt. Waverley North PS and the Department of Education & Training are required by law to protect the information provided by this enrolment form.

Health information is asked for so that staff at Mt. Waverley North PS can properly care for your child. This includes information about any medical condition or disability your child may have, medication your child may rely on while at school, any known allergies and contact details of your child's doctor.
